WHEREAS, in the opinion of the County Auditor, the public interests required that the Lake County Council, should be called to meet in special session at this time, for the purpose of considering an amendment to an Ordinance, a written notice was sent to each member of the Council, and proper advertisement made, and all other acts performed in accordance with the laws governing such matters.

And now in obedience to such call, come, Presiding Chair Christine Cid, David Hamm, Charlie Brown, Ted Bilski, and Randy Niemeyer, County Councilpersons, together with Tom O'Donnell and Ray Szarmach, County Council Attorneys. Councilmen Clorius Lay and Pete Lindemulder were absent.

In the Matter of Discussion – Possible Amendment of Ordinance Concerning Holiday Schedule for Calendar Year 2023

Bilski made the motion seconded by Hamm, to amend ordinance 1478B. Majority voted yes. Lay and Lindemulder were absent. Motion to amend ordinance 1478B carried 5-yes, 2-absent.

Szarmach – In Indiana there's a statute which list the legal holidays, however, new years eve is not one of them. So, each year, if you want to do New Year's Eve as a holiday you're going to have to do it in the original ordinance.
