Vote For One (1) Only

Currently, under the Constitution of the State of Indiana, a person charged with murder or treason is not entitled to be released on bail if the proof is evident or the presumption strong. Shall the Constitution of the State of Indiana be amended to provide that a person charged with an offense other than murder or treason is not entitled to bail if:

- (1) the proof is evident or the presumption strong; and
- (2) the state proves by clear and convincing evidence that no release conditions will reasonably protect the safety of any other person or the community.

PUBLIC QUESTION #3

Shall Tri-Creek School Corporation increase property taxes paid to the school corporation for no more than eight (8) years for the purpose of replacing lost property tax revenue, funding bus transportation, student programs, and school safety by imposing a property tax rate that does not exceed seventeen and thirty- eight hundredths cents (\$0.1738) and results in a maximum annual amount that does not exceed three million dollars (\$3,000,000)? If this operating referendum public question is approved by the voters, for a median residence of \$300,000, the property's annual property tax bill would increase by \$245 per year. The most recent operating referendum public question proposed by the school corporation was held in 2023 and failed.
