Vote For One (1) Only

Currently, under the Constitution of the State of Indiana, a person charged with murder or treason is not entitled to be released on bail if the proof is evident or the presumption strong. Shall the Constitution of the State of Indiana be amended to provide that a person charged with an offense other than murder or treason is not entitled to bail if:

(1) the proof is evident or the presumption strong; and

(2) the state proves by clear and convincing evidence that no release conditions will reasonably protect the safety of any other person or the community.

PUBLIC QUESTION #3

Shall the River Forest Community School Corporation continue to increase property taxes paid to the School Corporation for no more than eight (8) years for the purpose of sustaining educational and operational funding stability in response to reductions in property tax revenue, maintaining student transportation, supporting and retaining teachers and staff, and supporting essential health and safety initiatives, including the retention of school resource officers by imposing a property tax rate that does not exceed \$0.9912 and results in a maximum annual amount that does not exceed \$3,000,000. If this operating referendum public question is NOT approved by the voters, for a median residence of \$150,000, the property's annual tax bill would decrease by \$589 per year. If this operating referendum public question is approved by the voters, it would be a renewal of the most recent operating referendum public question passed in 2019 with a property tax rate of \$1.19.
