(2) To vote for any candidate for Township Board Member, you must select each candidate you wish to vote for. Your straight party vote will not count as a vote for any candidate for that office.

(3) If you wish to vote for a candidate seeking a nonpartisan office or on a public question, you must select the appropriate place on this ballot.

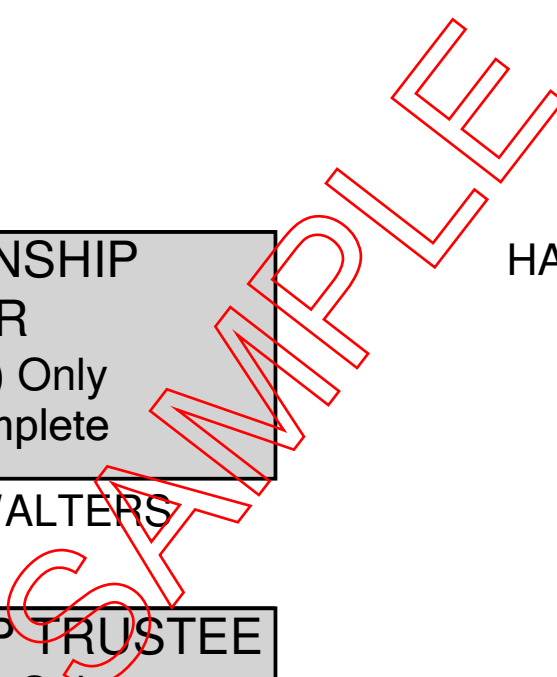
